Demolition work and impacts to the community: Noise – running air compressors, excavators, generators, general construction noise; truck traffic; street, alley, sidewalk closures; and dust.

Mitigations: Contractors will use water and other dust control

measures and will perform rodent abatement. Multiple adjacent properties will be demolished together to reduce frequency of street and alley closures. Contractor will install protective green screens on fencing. CTA will issue Construction Activity Notices (CANs) ahead of the start of work in your area.
